a. REVIEW PROPOSED BUDGET FOR FISCAL YEAR 2021

HIGHLIGHTS:

City Administrator Brent Spier went over a little bit of sales tax revenue for the year.

City Administrator Brent Spier went over a couple of major projects that are being proposed in the FY2021 budget which include possibly retiling the community swimming pool, painting of the City Hall and Clubhouse and construction on the new lot that was purchased behind City Hall.

Councilwoman Terrell, Parks and Pool Liaison, requested new pool furniture for the community pool.

Councilwoman Fenwick requested to have funds allocated for pool repair. She would like to see the pool repaired as a whole instead of bits and pieces throughout the year.

Mayor Otten stated that Obligation of Certificate could be an avenue to build the new City Hall.

Councilwoman Fenwick stated to keep the performance management and allow funds for employee raises.

Councilwoman Fenwick asked if we are keeping the Blackboard account which is used to notify residence in case of emergency or other important announcements? Brent Spier stated "Yes" - no plans of forgoing this account.

Mayor Otten mentioned a touchless payment system such as PayPal or an iPad with a touchpad system.

Councilwoman Fenwick asked Cheryl Hunter, City Accountant, if she saw anything in the budget that needs to be addressed? Cheryl stated that all looks good. She went over a couple of the new line items that would be included in the budget.

Scheduled the next Budget Workshop – July 21, 2020 prior to council meeting.


