CAN I LEAVE MY HOUSE?



ALL GALVESTON COUNTY RESIDENTS ARE ORDERED TO REMAIN AT THEIR PLACE OF RESIDENCE. YOU MAY LEAVE YOUR HOUSE ONLY FOR ESSENTIAL ACTIVITIES SUCH AS:

- OBTAINING MEDICAL SUPPLIES
- GOING TO THE DOCTOR
- GOING TO THE GROCERY STORE
- EXERCISING: WALKING, BIKING, HIKING, OR RUNNING
- CARING FOR A FAMILY MEMBER OR PET IN ANOTHER HOUSEHOLD
- GOING TO WORK

CAN I VISIT FAMILY AND FRIENDS?



ALL PUBLIC OR PRIVATE GATHERINGS OF ANY NUMBER OF PEOPLE OCCURRING OUTSIDE A SINGLE HOUSEHOLD OR LIVING UNIT ARE PROHIBITED.

THIS EXCLUDES CARING FOR A FAMILY MEMBER, FRIEND OR PET FROM A DIFFERENT HOUSEHOLD.

CAN I GO TO THE PARK OR ENGAGE IN OUTDOOR ACTIVITIES?



YES! WHILE THE GYM AND GROUP CLASSES ARE OUT, YOU CAN STILL CYCLE, HIKE, RUN OR WALK.

**REMEMBER:
IF YOU ARE USING SHARED OR OUTDOOR SPACES,
YOU MUST MAINTAIN SOCIAL DISTANCING OF AT
LEAST SIX FEET FROM ANY OTHER PERSON.**

**Q WILL I BE FINED OR GO TO JAIL IF I
DON'T COMPLY WITH THE STAY-
AT-HOME ORDER?**

A THOSE WHO DO NOT COMPLY WITH THE STAY-AT-HOME ORDER COULD FACE UP TO 180 DAYS IN JAIL OR A \$1,000 FINE. WE STRONGLY URGE ALL CITIZENS TO VOLUNTARILY COMPLY WITH DIRECTIVES FROM THE STATE AND COUNTY GOVERNMENTS, AS WELL AS FOLLOW GUIDELINES FROM THE CDC AND WHO.

LAW ENFORCEMENT WILL INTERVENE IF:

- THEY WITNESS OR RECEIVE REPORTS OF CROWDS OF PEOPLE GATHERING
- IF THEY RECEIVE A REPORT OF A BAR OR RESTAURANT HAVING CUSTOMERS EATING IN
- IF A BUSINESS IS NOT FOLLOWING APPROPRIATE SOCIAL DISTANCING PRECAUTIONS.

PER STAY-AT-HOME-ORDER:

DON'T FORGET TO COMPLY WITH THE SOCIAL DISTANCING GUIDELINES, INCLUDING MAINTAINING SIX FOOT SOCIAL DISTANCING. PUBLIC OR PRIVATE GATHERINGS OF ANY NUMBER OF PEOPLE OCCURRING OUTSIDE A SINGLE HOUSEHOLD OR LIVING UNIT ARE PROHIBITED.

- CRITICAL INFRASTRUCTURE: PUBLIC WORKS CONSTRUCTION, RESIDENTIAL AND COMMERCIAL CONSTRUCTION, AIRPORT OPERATIONS, WATER, SEWER, GAS, ELECTRICAL, OIL REFINING, ROADS AND HIGHWAYS, PUBLIC TRANSPORTATION, ETC.
